New National Aged Care Advocacy Program

The department held an open funding round in February-March this year seeking a single provider to deliver the new National Aged Care Advocacy Program (NACAP).

From 1 July 2017, the Older Persons Advocacy Network (OPAN) has been engaged to provide free, confidential and independent advocacy support to older people (including their families and representatives) who are receiving, or seeking to receive, Australian Government funded aged care services.

OPAN will deliver NACAP through its network of nine service delivery organisations across Australia. Each provides a nationally consistent model of independent advocacy, information and education focused on the rights of older Australians in need of care.

Session Title: Improving Skills in Recognising and Responding to the Abuse of Older People

Who is this for? Community and personal care workers; allied health workers; nurses; social housing workers; emergency services workers; family violence workers; case managers; assessment officers; volunteers; managers, etc.

During this training session, participants will:

- Explore the societal context of elder abuse and the rights of older people
- Identify elder abuse types and signs
- Examine the complexity of elder abuse, and barriers to recognising and reporting
- Understand duty of care and appropriate action to take when elder abuse is disclosed, witnessed or suspected
- Learn how to respond to reports of alleged abuse
- Find out where to go for advice and assistance
