Legislated Review of Aged Care 2017 – final report now available

On 14 September 2017, the Hon Ken Wyatt AO MP tabled the report of the Legislated Review of Aged Care 2017 (the Review).

The Review, led by Mr David Tune AO PSM, examines the impact and effectiveness of the changes implemented under the *Living Longer Living Better* reform package announced in 2012. It makes 38 recommendations for future reform to the aged care system.

An independent review was undertaken by Ernst and Young in mid-2017 to determine the adequacy of existing legislation and prudential standards that are currently in place to regulate refundable accommodation payments.
