Aider program

The AIDER (Assist Infirm, Disabled and Elderly Residents) program is a free, one-off service which supports some of our most at-risk community members.

The program helps people live more safely and confidently in their home in areas where bush fires may start.

The AIDER program is designed for people who have limited domestic support available from family, relatives, friends or other services. This could include older people, people living with a disability, and people who are already receiving community assistance and services. Their property must also be on bush fire prone land (land that can support a bush fire or be subject to bush fire attack).

World Elder Abuse Awareness Day - Monday 15 June

World Elder Abuse Awareness Day is on 15 June each year, to focus attention on one of the worst manifestations of ageism and inequality in our society: elder abuse.

Elder abuse is any act which causes harm to an older person and is carried out by someone they know and trust, such as a family member or friend. The abuse may be physical, social, financial, psychological, or sexual and can include mistreatment or neglect.

In many parts of the world elder abuse occurs with little recognition or response. Unfortunately, it is a global social issue which affects the health, wellbeing, independence, and human rights of millions of older people around the world, and an issue which deserves the attention of all in the community.

Extension to Royal Commission submissions deadline

The Royal Commissioners have announced that the deadline for general submissions to the Royal Commission into Aged Care Quality and Safety will be at the close of business on Friday, 31 July 2020. This means that the Royal Commissioners will continue to receive submissions for a month longer than the current deadline. [Read more](#)

The Commission published its first selection of general submissions received from members of the public and organisations on its website last week. Nearly 50 submissions were selected from submissions received in January 2019.
