National sign language interpreting service for aged care

A free sign language interpreting service will soon be available for senior Australians who are deaf, deaf/blind or hard of hearing. The service will provide appropriate sign language assistance to people who are receiving or want to access aged care services. Starting this month, it will be available to improve interactions with My Aged Care, aged care assessors, service providers and related organisations. Minister for Aged Care and Senior Australians, Richard Colbeck, said Auslan Connections would deliver the service ensuring those in need would receive much-needed support.

Serious Incident Response Scheme

A Serious Incident Response Scheme will be introduced by the Morrison Government to protect vulnerable and senior Australians from abuse and neglect. The initial \$23 million investment will be rolled out from July 1, 2021. Minister for Aged Care and Senior Australians, Richard Colbeck, says the scheme will be an important measure to guarantee transparency and keep our loved ones safe.
