## **FREE - Introducing the “ABC of Unit Costing”**

### **Expected availability date November 5, 2021**

The current pilot program is about to be finalised and has a range of resources (unit costing tool, workbook & short *how to use* video) to assist Commonwealth Home Support Program (CHSP) organisations to calculate the Unit Cost of specific service types.

While we wait for clarification about the broader payment in arrears approach, it is pertinent for organisations to be clear on the actual costs of delivering services. Having this data will also be of assistance when new contracts are negotiated (in relation to outputs and/or funding).

A working party made up of providers, peaks bodies and Stewart Brown Accountants, has been involved in the development and testing of the tool.

All resources will be made available at no cost and will be available on the key consultant, Carrie Hayter, website soon. Watch this space for more information.

## **Group Programs and COVID -19 Vaccination status**

The Commonwealth have advised one of our colleagues they have no specific advice around recommencing CHSP group programs and that providers should follow NSW Public Health Orders. We have now had some clarification from NSW Ministry of Health.

*'I have been in touch with our public health team, and aged care day centres should adhere to the same advice that is on the website for disability day programs (outlined below) ... this will soon be updated on the NSW Health website.'*

### ***Commencing disability day programs***

***On 11 October 2021 the Public Health (COVID-19 General) Order 2021 (Order) commenced, lifting the stay at home orders for all of NSW. In line with the new Order, disability day programs may recommence across all of NSW.***

*In arranging activities, day program providers should maintain COVID-19 safe practices including:*

- *encouraging all residents, staff and volunteers to be fully vaccinated*
- *ensuring everyone wears a mask when indoors, unless they are exempted*
- *encouraging regular use of alcohol-based hand sanitiser*
- *maintaining a distance of at least 1.5 meters from other people*
- *have COVID-19 safe plans in place*

*Staff and participants should not attend if they have any COVID-19 symptoms*

***Where participants are not fully vaccinated providers are encouraged to continue to provide flexible options including online service delivery, individual activities and avoid group interactions unless the participants are from the same household.***

## **New South Wales mandates COVID-19 vaccination for in-home and community aged care workers**

The New South Wales Government today announced that by 9.00 am on 25 October 2021, any person who provides in-home and community aged care services to a person must have received their first dose of a COVID-19 vaccine. This includes all in-home and **Commonwealth Home Support Programme** workers. Workers are required to receive a second dose of a COVID-19 vaccine by 9.00am on 29 November 2021. ## **Mandatory reporting on COVID-19 vaccination for all CHSP providers**

Mandatory reporting starts next week on **Tuesday 5 October 2021**, for all Commonwealth Home Support Programme (CHSP) and National Aboriginal and Torres Strait Islander Flexible Aged Care Program (NATSIFACP) home care providers on the COVID-19 vaccination status of the aged care workforce. Reporting is via [the My Aged Care portal](#) for providers. The new reporting requires CHSP and NATSIFACP home care providers to record de-identified data at a service level on the:

- total number of workers at each aged care service, and of those,
- the number of workers at each service who have received a single dose of a COVID-19 vaccine
- the number of workers at each service who have received all required doses of a COVID-19 vaccine.

## Workforce advisory services for aged care providers

In response to the Royal Commission into Aged Care Quality and Safety, the Australian Government aims to improve choice and transparency for senior Australians and elevate the quality and safety of care provided across the sector through fostering investment and innovation by providers and boosting their overall resilience. The aged care workforce is a vital component to ensuring providers can deliver high quality, safe and respectful care. To support this aim, Australian Government announced funding to deliver Workforce advisory services (WAS) as part of the 2021-22 Federal Budget. The WAS also aligns with the broader Australian Government priorities to increase workforce skills and capabilities, especially in the aged care industry. PwC has been commissioned by the Department of Health to deliver the confidential and free WAS to the aged care industry alongside the [Business advisory services \(BAS\) program](#).

## Food Relief during COVID-19
